Privacy Notice for the 2026 Annual General Meeting of Shareholders

## Privacy Notice for the 2026 Annual General Meeting of Shareholders

The Company realizes the importance of personal data of shareholders and/or proxy holders. Accordingly, the Company has implemented the privacy notice in compliance with the Personal Data Protection Act B.E. 2562 (2019), as follows:

### 1. Personal Data Collected by the Company

It is necessary for the Company to collect your personal data, i.e. name, surname, address, telephone number, facsimile number, identification number, passport number, tax identification number, shareholder registration number, number of shares, bank account number, photo, video, audio, e-mail, IP Address, electronic traffic data, etc.

For the purpose of identity verification, we may request copy(ies) of your personal identification data such as identification card, government officer identification card, driving license, passport, or other documents which may contain sensitive personal data such as religion or blood group. Therefore, we kindly request you to redact such sensitive personal data. Otherwise, you authorize us to redact such sensitive personal data. In any case, the relevant personal identification document remains in full force and effect. In the event that we are unable to redact such sensitive personal data due to restrictions, we reaffirm that the sole purpose hereof is identity verification and that we have no intention to collect or use any such sensitive personal data.

### 2. Collection of Personal Data

The Company will collect your personal data which is directly provided by you or from Thailand Securities Depository Company Limited, which is an authorized the Company's securities registrar.

### 3. Purposes for the Collection, Use and Disclosure of Personal Data

The Company is required to collect, use, and disclose your personal data for the following purposes:

- To arrange the Shareholders' Meeting, which includes delivering documents in relation to the shareholders' meeting, verifying identity at the registration to attend the Meeting, vote processing, preparing minutes of the Shareholders' Meeting and any action in relation to such Shareholders' Meeting.
- To disclose the minutes of the Shareholders' Meeting or photo and video recording of the Meeting on the Company's website.
- To carry out any action in relation to the dividend payment or the benefits to the shareholders
- To organize the Company's activities which includes the communication through the Investor Relations or other channels designated by the Company.
- To undertake any obligation in compliance with the laws and/or cooperation with the courts, government agencies, regulatory bodies and law enforcement agencies.

The Company will collect, process and/or disclose your personal data for the aforementioned purposes only as required by law or for the performance of a contract by lawful basis, or for the Company's legitimate interests, and your consent, (as the case may be).

In the case where the Company is required to collect, use and/or disclose your personal data as required by law, or for the performance of a contract, or as consented by the personal data owner (as the case may be), any failure to provide the necessary personal data for such purpose to the Company may impede the Company from managing and performing any agreement you entered into with you, including your entitlement to any rights or benefits, as a shareholder (if any).

#### **4. Personal Data Retention Period**

The Company retains your personal data only to the extent necessary to achieve the purposes specified in this Privacy Notice. The Company will retain your personal data for as long as you remain a shareholder of the Company and for a period of 10 years thereafter from the date you cease to be a shareholder, or for such longer period as necessary to comply with applicable laws, to establish legal claims, or to exercise legal claims.

The Company has implemented appropriate security measures to safeguard personal data, covering data stored in documentary form, electronic systems, computer systems, or other tools and devices, in accordance with recognized standards, to ensure the Company's personal data security. Such measures include protection against loss and unauthorized access, use, alteration, amendment, or disclosure of personal data, or any unlawful processing without proper legal authority.

#### **5. Your Rights as a Data Subject**

As the owner of personal data ("Data Subject"), you have the rights as stipulated in the Personal Data Protection Act B.E 2562 i.e. right to withdraw the consent, right to access and obtain a copy of your personal data, right to correct your personal data, delete or destroy your personal data, right to request suspension of the processing of your personal data, right to transfer your personal data, right of complaint, right to object to the collection, usage or disclose of your personal data.

#### **6. Disclosure of Personal Data to Third Party**

The Company may be required to disclose your personal data to individuals, juristic persons or other agencies involved in carrying out the purposes specified in Clause 3, including IT system service providers, electronic and print media service providers, data storage service providers, document delivery service providers, venue and facility service providers, event organizers, banks, advisers, professional service providers, or other related service providers, as well as regulatory authorities, government agencies, or pursuant to orders of competent officials.

Moreover, the Company may be required to disclose your personal data to the public where required by law or under principles of good corporate governance principles, for example, in the minutes of Shareholders' Meeting. etc.
